Current agreement:

- The VR Bank has written off a further € 270.000. This is approximately the amount which the VR Bank had calculated as unauthorized interest according to our books. So this interest is refunded fully and this discrepancy fixed.
- Our liabilities to VR Bank therefore go down from € 1.420.000 to € 1.150.000. We have already brought in € 350.000 of own resources from new liabilities of the circle around Jonathan including unpaid interest and amortizations to the VR Bank since October 2009. .
- The auction appointment on September 6th is removed.
- VR Bank is ready to finance the difference of € 800.000 and we are free to realize another solution.

In the spirit of a new time of common vision and mutual assistance: thanks to the people around Jonathan, our vision is that Jonathan gets financed and supported by our friends. As Chuck Spezzano teaches: "Friends helping friends". Then Jonathan is in the hands of people whose hearts are in the place. Everyone wins together with the promotion and success of Jonathan. Together we make it possible.

Here are the possibilities of being part of the realization:

**Cash in advance** for events which happen at Jonathan in the next years. This cash in advance can be taken for the Sahara-retreat, seminars organized by Jonathan like "Bereit für den Wandel", hotel costs, balloon flights. Further seminars are planned.

**A Loan** of a minimum of € 3.000 with 4% interest per annum. Minimum time of investment is two years. This loan is protected with the land as collateral.

**Participation in Jonathan as a Co-partner in the KG:** Liabilities of at least € 25.000.
